SAFE AND RELIABLE TRANSPORTATION FUNDING IS CRITICAL TO THE SUCCESS OF OUR ECONOMY


One of the most fundamental tasks of government is to ensure that people and goods can move safely and efficiently. Indeed, that task is at the heart of the Ohio Department of Transportation's mission statement: to provide the safe and easy movement of people and goods from place to place. The Department takes this mission seriously, which is why we have embarked on a comprehensive, 18 month study to identify stable and reliable funding for our transportation network for generations to come.

The gas tax is a highway user fee and represents the largest funding source for transportation projects in Ohio. However, as vehicles become more fuel efficient and electric vehicles more prevalent, drivers are using less fuel, and therefore paying less in gas tax. This, in turn, results in less revenue that Ohio can use to maintain and repair our state's transportation infrastructure. While reducing our

reliance on fossil fuels is good for our environment, this decrease in funding has not led to a decrease in the demands placed on our system.

In 2019, the Ohio Legislature took a step to address this chronic funding shortfall by enacting an increase in the gas tax, which helped alleviate—but not eliminate—the shortfall. While the gas tax increase is helpful, the Department knows this does not solve the long-term problem. Trends both in Ohio and nationally point to increased demand for fuel efficient and electric vehicles. Fuel consumption in Ohio is expected to fall about 40% through 2040 due to the improved fuel efficiency of the vehicle fleet. This will continue to erode the effectiveness of the fuel tax to provide sufficient funding for our transportation system. Ohio must look at alternative funding mechanisms that move us away from our reliance on fuel and provide stable and reliable funding well into the future.

To study reliable alternatives, in 2021, the Ohio Department of Transportation received a federal Surface Transportation System Funding Alternatives (STSFA) program grant to study revenue alternatives. Ohio is using this federal grant to study the feasibility of one or more alternative revenue systems in Ohio and to



recommend next steps.

In March, the Department took the first step in this process by forming an external advisory committee, whose purpose is to aid the Department in evaluating various alternative funding mechanisms. The committee is comprised of 18 members, representing a broad range of interests, from business to agriculture to transit to rural communities, and more. The common thread among all these organizations is that they all rely on a safe and efficient transportation network to fulfill their missions. The members are providing critical feedback throughout the study, on the principles that must underlie a future funding system.

To date, the Department has facilitated three meetings. The information presented has been comprehensive, providing committee members with a substantial amount of data and analysis with which to make recommendations. The meetings have discussed a range of topics, including a broad review of the economic needs of the different regions of the state, a comprehensive review of alternative revenue mechanisms other states are using, as well as an opportunity to evaluate how we talk to the public about our transportation system and funding.

This public engagement plan is at the heart of this study. No effort to stabilize revenues for our transportation system will be successful unless we explain to the public the importance of our transportation network, but also why the current funding model is unsustainable. That is why a robust public education plan is being developed as part of this project. This outreach effort will include public surveys and focus groups conducted around the state to gather feedback from Ohio citizens about their perceptions of transportation funding and the transportation needs of the state. These surveys and focus groups, which will be completed by late fall, will inform the future work and recommendations the committee will make regarding sustainable funding sources. After completion of the public engagement plan, the committee will reconvene early next year to evaluate the alternative revenue mechanisms and provide a recommendation on how to move forward.

Regardless of background, every Ohioan relies on a safe and efficient transportation system to go about our daily lives: to get to work, go to the grocery store, go to critical doctor appointments, see family, and more. We at the Ohio Department of Transportation are committed to our mission of providing a safe and efficient transportation network for every citizen. This project offers a path to identify and build support for reliable funding for this most critical of assets. We look forward to continuing this conversation with you.

LEGISLATIVE UPDATE: PERSEVERING AMID UNCERTAINTY

As the Ohio General Assembly drew to a close in the midnight hour on June 1, so did our weary Government Affairs team which held vigil across the street at the Ohio Chamber's office. The evening marked the wildly successful kickoff of our "Cocktails and Commerce" event, a nighttime spin on our traditional "Coffee and Commerce" morning events held to connect Chamber members, state legislators, and legislative staff. The marathon House and Senate sessions that evening also concluded – likely until after the November 8th general election – a peculiar half-year of legislative activity frequently interrupted by uncertainty over legislative district maps and primary election dates.

Thankfully, the Ohio Chamber's Government Affairs team was thrilled to claim victory for Ohio's business community on five bills sent to Governor DeWine in the first six months of 2022, coupled with five priority measures previously enacted in the last half of 2021. The legislative wins for 2022 include:

- House Bill 447 a measure to clarify and codify when work-from-home injuries are compensable under Ohio's Workers' Compensation system.
- House Bill 175 legislation that revises the Ohio EPA's definition of, and regulatory authority over, ephemeral streams that strikes an equitable balance between environmental stewardship and eliminating unnecessary red tape for economic development.
- House Bill 126 a bill that makes major revisions and restrictions to the abused practice of third-party challenges to real property values established by local county auditors.
- Senate Bill 47 an important change to Ohio's overtime statute that clarifies when "de minimis" amounts of time may be disregarded when calculating overtime pay.

Senate Bill 9 – a critical measure that both reduces and curtails the implementation of state agency rules and regulations that limit economic growth and increase compliance burdens.

Making Sense of Redistricting

As you may be aware, the current two-year General Assembly also coincides with the state and federal redistricting efforts that occur every 10 years when population shifts are noted via the census. Unfortunately, the implementation of what were expected to be smoother, fairer redistricting processes (previously approved by Ohio voters as a constitutional amendment) was anything but. In a series of five Ohio Supreme Court rulings, assorted versions of proposed state and federal legislative maps were rejected with the same 4-3 breakdown of justices. Through a 2-1 federal district court decision, the "third" versions of state legislative maps were implemented despite being rejected by the Ohio Supreme Court as unconstitutional.

This messy ordeal resulted in a bifurcated primary election, with statewide candidates appearing on the original May 3 ballot while legislative and State Central Committee candidates are delayed until an August 2 election. It remains to be seen how the multiple rewrites of districts, which created havoc and uncertainty among incumbents, candidates and especially voters, will impact races in August. According to the Ohio Secretary of State's office, voter turnout for the May 3 primary was 20.88 percent, meaning of nearly 8 million registered voters, just over 1.6 million cast a vote. These already dismal numbers are likely to decline significantly for the August 2 races, which could spell trouble for incumbents and create even more storylines heading into both the November General Election and lame duck legislative agenda.

Summer Advocacy

The Ohio Chamber has recently updated its candidate questionnaire and supplied it to all legislative candidates seeking consideration for endorsements and/or Ohio Chamber PAC financial support. Additionally, Chamber staff and members have conducted numerous interviews with existing legislators and new candidates and will

continue them over the summer to identify champions for business interests and those who align with Chamber priorities.

The summer and autumn months may be a grind for those on the campaign trail, but they are also perfect opportunities for our Chamber members to engage with elected officials. Our Government Affairs team has two ways to connect Chamber members with either Ohio House or Ohio Senate legislators. First, through the generous and voluntary financial contributions of our members and staff, we will be traveling the state to attend numerous campaign events and award Ohio Chamber PAC donations. From golf outings to evening receptions, if you have an interest in accompanying our team, please contact us and we would love to have you join us.

Second, with legislators back home in their districts reconnecting with constituents, it's a chance for us to coordinate site visits or local meetings between our Chamber members and elected leaders. If you have a facility or office that you're willing to host for a tour or policy discussion, our team stands ready to facilitate a meeting. In-district meetings are consistently the best way for the business community to resonate with policymakers, showcase operations and directly illustrate their contributions to the local economy through their goods and services, area employment and philanthropic gestures.

OHIO CHAMBER CONTINUES ITS ADVOCACY EFFORTS BEFORE OHIO COURTS

Over the past year, the Ohio Chamber has sought to bolster our advocacy efforts before Ohio's courts. This increased emphasis on the judiciary was done in recognition of the impact a civil justice system has on a state's business climate because employers suffer when judges fail to promote stability and predictability. Whether it is through higher operating costs, runaway jury awards, or more frivolous lawsuits, an unpredictable court can wreak havoc on business owners and the state's business climate.

To help stop courts from having a detrimental impact on your business, the Ohio Chamber has filed 13 amicus curiae briefs in courts across Ohio in the past 12 months. An amicus curiae (Latin for "friend of the court") brief provides an opportunity for the Ohio Chamber to discuss why a court should – or shouldn't – rule in a certain way. In our briefs, we tell the court how a particular outcome could harm Ohio businesses, emphasis onhow the law should be applied, and illuminate why this is a matter of statewide importance – which is a key factor in the Ohio Supreme Court agreeing to hear a case.

The Ohio Chamber has the unique ability to share why a lawsuit is a matter of statewide significance because we represent the voice of all Ohio businesses regardless of their industry, size or where they are located.

To highlight the Ohio Chamber's advocacy, the following is a summary of select amicus briefs the Ohio Chamber has filed recently and the attorneys and law firms who represented us:

Gibson Bros, v. Oberlin College

In the Ohio Chamber's continuous efforts to defend the state's tort reform laws because of their positive impact on our business climate, we filed an amicus brief challenging the calculation of punitive damages awarded by lower courts to Gibson Bros. The previous courts misapplied the law when they used uncapped non-economic damage awards to determine the punitive damage amount. This miscalculation resulted in a jury award of more than \$33 million.

If left untouched, that excessively high award would harm Ohio business and our civil justice climate because companies would be on the hook for paying unreasonable punitive damage awards, despite an Ohio law that caps how much a plaintiff can receive in non-economic damages and punitive damages.

The Ohio Chamber in our amicus brief urged the Ohio Supreme Court to accept jurisdiction over the case to provide guidance to lower courts on how to properly calculate punitive damages accordance with Ohio law and the legislature's intent. In fact, the brief speaks to how the law was designed to protect businesses from the very type of punitive damage verdict that was awarded in this case.

The outcome of the case is still pending, and we still await a decision from the Ohio Supreme Court as to whether they will accept jurisdiction over the case.

In re Matter of the Application of Firelands Wind

As Ohio companies seek to expand their energy generation options, the Ohio Chamber is committed to advancing market based policies that drive an all of the above energy portfolio. In the courts, this means filings amicus briefs when decisions approving new energy generation projects are challenged.

In this instance, the Ohio Power Siting Board had approved a new wind-powered electric generation facility in Huron County. This project can produce nearly one million megawatt hours and is designed to help meet the demands of businesses that are seeking renewable energy goals. Despite the positive economic impacts, some residents near the facility challenged the Siting Board's approval.

At the Ohio Supreme Court, the Ohio Chamber filed an amicus brief in support of the project. The Chamber's brief focused on showing the justices why the Huron County facility serves the public interest – which is a requirement in the Power Siting Board approval process. We argued the facility serves the public interest because there is great demand for renewable energy from businesses locating to Ohio and will help the Buckeye State capitalize on our potential to be a leading renewable energy producer in the Midwest. Likewise, we mention how the project will lead to more than \$170 million in economic outputs including more than one thousand construction jobs that pay over \$62 million in wages.

While a final decision from the court is pending, the briefing stage has recently concluded, so oral arguments could be held later this year.

Jerry Wray, Director of Ohio Dept. of Transportation v. Ice House Ventures

Contracts are a fundamental part of any business. Whether it is a contract for the purchase of goods, services, or real estate, businesses rely upon these agreements to set obligations between them and other parties. Reliance on these contracts is essential when operating a company, so businesses suffer when courts are able to re-write contracts or make them unenforceable.

Unfortunately, that is exactly what happened in this lawsuit. Here, the Ohio Department of Transportation (ODOT) filed an eminent domain action seeking to take a portion of Ice House Ventures property located in Columbus. After negotiations lasting more than two years, an agreement was reached and submitted to a court to create a settlement order. This settlement order created obligations for ODOT and provided remedies for the business should ODOT not meet its obligations. When ODOT failed to adhere to their obligations, Ice House Ventures sought their remedy and a court found ODOT had breached the contract. However, on appeal, three judges upended settled contract law and found there was "no meeting of the minds" despite ample evidence to the contrary.

To restore stability and prevent future courts from relying on this dubious opinion from the appellate court, the Ohio Chamber filed an amicus brief in support of Ice House Ventures. In our brief, we discuss how the appellate court's decision could lead to mass confusion amongst business owners and result in contracts

having to define the most basic contract terms to adhere to this new "meeting of the minds" standard. We ask the Ohio Supreme Court to overturn the lower court's decision to bring greater predictability to the enforcement of contracts.

The Ohio Supreme Court has accepted jurisdiction in this lawsuit, so we are hopeful they agree with our proposition, and we look forward to their decision.

"A HAND UP" TO OHIO WORKERS

State Representative Dontavius Jarrells

House Bill 410 in Ohio's 134th General Assembly, which expresses the General Assembly's intent to alleviate benefit cliffs in Ohio and establishes the Actionable Help And New Dignity for Upward Progression act, or "A Hand Up," is a necessary and winsome step in helping Ohio's workers transition from public assistance to the working world.

Benefit cliffs occur when an individual receiving public assistance experiences an increase in earnings that suddenly no longer qualifies them for that program, leaving many of Ohio's workers behind. There are a large number of workers who are capable and motivated to transition into the workforce. However, the economic hardship of losing public assistance leaves them trapped in a cycle of dependence. Individuals should not experience an abrupt cut-off in benefits when their earnings are increased minorly and sometimes temporarily. Not only do benefit cliffs disincentive individuals to advance their skills and gain more working experience, but they also leave many without the essential economic support they need for themselves and their families while pursuing such opportunities.

That's why State Rep. Gary Click (R-Fremont) and I worked to develop House Bill 410 to support Ohio workers and provide more bridges to opportunity with the creation of 'A Hand Up.' There are various public assistance programs that individuals can experience benefit cliffs from, like Medicaid, Supplemental Nutrition Assistance Program (SNAP), and child care. Our 'A Hand Up' legislation would support Ohioans with the resources they need to pay for increased deductibles, co-pays, and childcare premiums. The law would also encourage more investment in programs that help workers increase job skills and marketability, advocate for more flexibility in qualifying for programs, and promote financial literacy. By eliminating obstacles to financial independence, Ohioans receiving public assistance can reach more economical and workplace opportunities.

It's time for Ohio to address the reality benefit cliffs pose on our businesses and constituents. House Bill 410 is an excellent start to building a better Ohio for all of us.



State Rep. Dontavius Jarrells is currently serving in his first term representing Ohio's 25th House District, which includes portions of Columbus, Clinton Township and Mifflin Township.
